Resiliency Florida

Building resiliency for Florida's children and families is a top priority for FDOE. Resiliency Coaches serve as one of the first layers of support to help children develop essential skills like grit, perseverance and problem-solving, and support children as they build resilience to face day-to-day challenges.

To complete the Resiliency Coach supplemental training, individuals must have met current volunteer screening requirements with the local school district and have completed an online training with a four-hour volunteer practicum. Best Practices for Inclusive Education (BPIE) Assessment for Students with Disabilities Reminder

The BPIE assessment is an internal process designed to facilitate the analysis, implementation and improvement practices for SWD who are served in regular classes. Section 1003.57, Florida Statutes (F.S.), requires that once every three years, each school district and school complete a BPIE assessment. Florida Inclusion Network (FIN) facilitators are required to assist school districts

in this process. The results of this process must be included in each school district's ESE policies and procedures. School BPIE assessments should be completed prior to the end of the school year. Restraint Data for January 2025 is Now Available

January 2025 data for restraint incidents submitted to the Involuntary Examination, Restraint, and Seclusion (known as IERS) web application is now available. The data have been posted at Program Accountability, Assessments & Data Systems and can be located by scrolling down to the section titled "SWD Restraint Data – SY 2024-25," and selecting the appropriate month. Pursuant to section 1003.573(8), F.S., "The department shall maintain aggregate data of incidents of restraint and disaggregate the data for analysis by county, school, student exceptionality, and other variables, including the type and method of restraint used. This information shall be updated monthly, deidentified, and made available to the public through the department's website."

New Versions of the 2025 ESE Parent Survey

FDOE has corrected the errors in the previously posted electronic and paper-based versions of the 2025 ESE Parent Survey. Please use these revised versions of the 2025 ESE Parent Survey for the current academic year: electronic ESE Parent Survey and paper-based ESE Parent Survey. Note that the QR code and link to the electronic version available prior to February 28, 2025, have been deactivated and will not work as the new survey version has launched. Do not have parents re-take the survey as their responses have already been collected. Previously collected responses and new responses will be merged and represented on the Response Rate Dashboard for Indicator 8: Parental Involvement. The survey is open to all parents of children with an individual educational plan (IEP) receiving ESE services from preschool through grade 12. It is not intended for parents of students receiving only gifted services through an educational plan. Students with disabilities aged 18 or older may complete this survey. The survey features straightforward questions and takes less time to complete, making it easier for parents to participate. District- and school-level results will be available at the close of the survey window in June 2025. The survey can be completed online at 2025 ESE Parent Survey.
