The summer end-of-term (T1E) and fall beginning-of-term (T2B) data submission window opens on Friday, August 13, 2021 for the following databases and terms:

• Admissions Database: Summer end-of-term (T1E)

• Facilities and Capital Outlay Database: Summer end-of-term (T1E)

• Personnel Database: Summer end-of-term (T1E)

• Student Database: Summer end-of-term (T1E)

• Student Database: Fall beginning-of-term (T2B)

# Adult Education Program Load Date

All colleges with adult education programs must submit and load all adult education data for summer end-of-term and fall beginning-of-term by the end of processing on Friday, September 3, 2021. The <u>Adult Education Data Certification form</u> is available on our website and is due on Tuesday, September 7, 2021. Colleges should continue to submit adult education records throughout the submission window, adding and correcting data as necessary for a complete and accurate record at close.

### Load Date for All Colleges

All colleges must successfully submit and load summer end-of-term and fall beginning-of-term data by the end of processing on Friday, September 10, 2021. The submission window closes by the end of processing on Friday, October 1, 2021. Certification of these data submissions and the integrated database are due Monday, October 4, 2021. The certification form is available on our <a href="website">website</a> and must be submitted using the specified certification file name defined within the form.

To assist you in meeting data reporting requirements, scheduled processing times for your submission files are available in the <u>2021-22 Data Submission Procedures manual</u>. The associated <u>2021-22 reference files</u>, including file formats, are available for download from our website.
