## **EXECUTIVE SUMMARY**

Florida's school improvement system, also known as Differentiated Accountability (DA), requires schools that earn a D or F grade complete a process for improved student performance. Any school earning a D or F grade immediately enters the DA system and is provided assistance of escalating intensity to schools not meeting accountability standards by the DA staff.

There are 69 schools in 24 districts requiring implementation of turnaround option plans for the first time. This action item is for approval of the turnaround option plans for 46 schools in 17 districts for 2016-17. The remainder of the plans will come before the Board at a later date, after additional review and clarification of the plans. These schools earned D or F grades for three consecutive years beginning in the 2012-13 school year. Given the hold harmless provisions of s. 1008.34(7)(a), F.S., schools identified as "Planning" for the 2014-15 school year that did not improve to a "C" or higher, continued in that status through 2015-16, which lengthened the process an additional planning year.

According Section 1008.33(4)(b)1, Florida Statutes, any school earning a D grade for three consecutive years must implement the district-managed turnaround option. This affects schools on the list, which are shaded in orange.

Upon approval, the district will implement its turnaround option plan for two school years unless the school improves to a C grade or better in 2016-17. At the end of the two year implementation period, those districts whose schools have not improved to a C grade or better, will present a new turnaround option plan to the state board for consideration.
