### **Part I: Needs Assessment**

# **Item 1**: Description of the needs assessment methodology and summary of the results.

This is the first year that the Bradford Intervention Center has received a school grade. The BIC scored 27% of the total possible points placing it in the category of an F School.

The specific breakdown of the 2017 School Grade data from FLDOE EDSTATS is as follows:

ELA Proficiency: 0% (BIC) 55% (State Average) ELA Learning Gains: 17% (BIC) 54% (State Average) C-C Acceleration: 6% (BIC) 55% (State Average)

Grad Rate: 86% (BIC) 81% (State Average)

Although the BIC exceeded the state average in Graduation Rate for BIC seniors, challenges remain throughout all grade levels in the area of ELA proficiency and learning gains. The BIC received no scores in mathematics proficiency or learning gains.

Based on the district's FOCUS student information management system, as of October 4, 884 periods have been missed out of 3,408 for an attendance rate of 75%.

# **Item 2**: Rationale for the turnaround option(s) selected.

After careful review and consultation, the District selects to close the Bradford Intervention Center and Reassign the students to their home schools. The home schools are Bradford High School, Bradford Middle School, and Starke Elementary School. All of these schools are higher-performing and received a grade of C for the 2016-2017 school year.

Elementary BIC Students will be reassigned to Starke Elementary School which received a grade of C in 2017.

Middle School BIC Students will be reassigned to Bradford Middle School which received a grade of C in 2017.

High School BIC Students will be reassigned to Bradford High School which received a grade of C in 2017.

The reassignment process shall begin upon approval of this plan. Substantial completion of the process, including the amending of Individual Education Plans to reflect the reassigned school is set for November 30, if not sooner.
