1. **District Number, Current Instruction/Service** must be numeric and in the range 01-70 or 72-76 and must be correct for the district submitting the data. -record rejected-

2. **School Number, Current Instruction/Service** must be numeric in the range 0001 to 9899 and exist on the Master School Identification file as a valid school number in the district of enrollment. -record rejected-

3. The first nine positions of **Student Number Identifier, Florida** must be numeric. The tenth position of **Student Number Identifier, Florida** must either be an "X" or numeric. If the tenth position of **Student Number Identifier, Florida** is numeric, the first two digits must be a valid district number in the range 01-76. If the tenth position of the **Student Number Identifier, Florida** is an "X", the first three positions may not all be zeroes.

Note: For additional information on **Student Number Identifier, Florida** refer to DOE Information Database Requirements: Volume I -- Automated Student Information System Manual.

4. **Survey Period Code** must be F, W, or S and must be correct for the submission specified by the district. -record rejected-

5. **WDIS Reporting Year** must be correct for the submission specified by the district. -record rejected-

6. The **Transaction Code** must be A, C, or D. For the original transmission, only A is valid. For subsequent batch/update submissions, if A is specified then the record must not already exist on the database; if C or D is specified then the record must exist on the database. -record rejected-

7. Each WDIS Student End of Term Status record must be unique based on the keys of **District Number, Current Instruction/Service; Student Number Identifier, Florida; Survey Period Code; WDIS Reporting Year; and Grade Level**. If more than one WDIS Student End of Term Status record is submitted for a student, only one record with **Grade Level** = 09-12 will be accepted and only one record with **Grade Level** = 30 or 31 will be accepted. -record rejected-

8. **(Modified 04/2020) Diploma Type** must be W06, W07, W10, W27, WGA, WGD, W43, W45, W52, W54, W55, W58, W59, **W60**, W61, W62, W63, **WCO**, WD1, WFT, WFW, WRW, WXL, WXT, WXW or ZZZ. -record rejected-

9. **Certificate of Completion, Type** must be W08, W8A, W8B, W09, W44, W53, W56, or ZZZ. -record rejected-

10. **Florida Education Identifier (FLEID)** is alphanumeric and must be entered as "FL" in the first 2 positions followed by twelve numeric digits and must be greater than FL000000002000. No blanks or spaces are allowable. -record rejected-

13. **Grade Level** code must be 09-12, 30, or 31. -record rejected-

22. If **Certificate of Completion, Type** is W08, W8A, W8B, W8C, or W09, **Grade Level** must be one of the grades 09-12. -record rejected-

23. If **Diploma Type** is other than ZZZ, then **Certificate of Completion, Type** must be ZZZ and vice versa. -record rejected-

29. **(Modified 04/2020)** If **Diploma Type** is W43, W45, W52, W54, W55, W58, W59, **W60**, W61, W62, or W63 then **Grade Level** must be one of the grades 30 or 31. -record rejected-

30. If **Certificate of Completion, Type** is W44, W53, or W56, **Grade Level** must be 30.

70. Each WDIS Student End of Term Status record must have a matching WDIS Student Demographic record based on **District Number, Current Instruction/ Service; Student Number Identifier, Florida; Survey Period Code** and **WDIS Reporting Year**. -state validation-

71. If **Diploma Type** = W06, then **Exceptionality, Primary** may not be **C, G, H, J, K, O, S, V** or **W**. -state validation-
