VERSION DESCRIPTION

Major concepts/content

 - Describe laws related to speeding, as well as penalties for racing on the highway.
 - Describe situations where vehicle speed must be adjusted for road and weather conditions.
 - Describe the need for identifying potential hazards in traffic, making predictions about possible occurrences, making safe decisions for action based on minimum risk, and the appropriate execution of these decisions.
 - Describe Driving Under the Influence (DUI), Zero Tolerance, and Implied Consent laws and the consequences for non-compliance
