EXECUTIVE SUMMARY

Pursuant to Rule 6A-1.099811(11)(b), F.A.C., a school district may choose to enter a two-year Turnaround Option Plan-External Operator (EO) with State Board approval, as set forth in paragraph (7)(b). For the below schools, the State Board of Education approved the two-year Turnaround Option Plan-EO in July 2019. Due to the COVID-19 pandemic and the pause on accountability in 2019-20, and the districts not "opting in" to their 2020-21 school grade, the schools will enter into Year 2 of the previously approved Turnaround Option Plan-EO in 2022-23.

Pursuant to Rule 6A-1.099811(11)(b)5., F.A.C., the school district shall enter into an annual contract with the EO. The districts and schools below will not be changing the State Board of Education-approved Turnaround Option Plan or EO provider and are requesting approval of the annual EO contract for the 2022-23 school year.
