History of Warrington Middle School

- Since 2012, Warrington Middle School has earned a school grade of D or F and identified as in Turnaround.
- In 2019-20, Warrington Middle School entered into the second year of the State Board of Education approved Turnaround Option Plan-External Operator (EO) with 2021-22 EO services provided by Learning Sciences International (LSI).
- In March of 2021, the State Board of Education placed requirements on Escambia County Schools for Warrington Middle School. The requirements were met.
 - Replace the principal;
 - Replace the External Operator; and
 - 80% of English Language Arts/Reading and mathematics teachers must have three or more years of teaching experience and a state Value-added Model (VAM) rating of Highly Effective or Effective.
