Hi Candy,

I have reviewed the District comments and our follow up emails regarding the disclosure issue and feel like there is a disconnect here. The electronic version we provided you contains all the final versions of our application. I have no explanation as to how the hard copy did not reflect the same information. Regardless, the disclosure was made at the time of submittal and I apologize for any confusion the difference between the two document sets may have caused.

To further the point regarding disclosure, the questions regarding the different relationships between the companies I have an ownership interest in and how they tie into development were asked by the county, in a straight forward way, during our initial capacity interview for the Navigator Academy of Leadership Davenport K-8 school. Everyone on the NAL Board knows the relationship between my companies and the schools and why we do what we do - it's to save the schools money, period. The reason, and I paraphrase, we said we were using this delivery method at the outset of development for Navigator Academy of Leadership Davenport is because we thought we could save the school significant monies by doing so. Indeed, our track record with the K-8 school demonstrates that our delivery methodology has and will continue to save NAL money in a very significant and substantial way.

When asked about the relationship or structure during this most recent capacity interview for the high school the answer was "it's all the same..." (paraphrase). The answer remains <u>it's all the same</u> as it clearly benefits the school compared to the alternative methods for development. If we can compare a withdrawn application

to this application, then we should be able to compare past conversations and delivery methods regarding development and construction to this application, as well.

Section 1002.33(6)(b), Florida Statutes provides:

(b) A sponsor shall receive and review all applications for a charter school using the evaluation instrument developed by the Department of Education. A sponsor shall receive and consider charter school applications for charter schools to be opened at a time determined by the applicant. A sponsor may not charge an applicant for a charter any fee for the processing or consideration of an application, and a sponsor may not base its consideration or approval of a final application upon the promise of future payment of any kind. Before approving or denying any application, the sponsor shall allow the applicant, upon receipt of written notification, at least 7 calendar days to make technical or nonsubstantive corrections and clarifications, including, but not limited to, corrections of grammatical, typographical, and like errors or missing signatures, if such errors are identified by the sponsor as cause to deny the final application.

Please allow this correspondence to serve as the technical or nonsubstantive correction/amendment necessary to ensure that the hard copy and electronic copy are aligned. Specifically, page 97, Addendum B of the hard copy should, as does the electronically submitted copy, provide that:

"...However, the Board does anticipate that it may contract directly with Radius Development Group and Gladiator Contracting Services, LLC, for construction and other services if and when the Board determines that it is the school's best interest to do so based on favorable pricing and prior experiences utilizing those companies at other Navigator campuses. Jeremy Calkins, the Managing Principal of Compass Charter Schools, is also a member of both Radius Development Group, LLC and Gladiator Contracting Services, LLC."

Neither the School Board nor the charter applicant would be prejudiced by technical and non-substantive revision and Florida Statutes expressly permits the inclusion.

We respectfully but firmly disagree with Polk County's assumption that a potential conflict of interest might arise based on a non-executed and non-realized agreement that this would constitute a conflict of interest. If needed, we are fully prepared to present arguments in defense at the next regularly scheduled school board meeting. The language you reference is an appropriate disclosure of a potential future agreement. When the time comes, any and all decisions regarding future developments will be proceeded by a full discussion and full disclosure as is always the case. Further, no conflict of interest exists between any board members and any members of the management company.

I would also like to make a point about the concerns raised about the proposed budget. The County has acknowledged that we have built a sizable unrestricted fund balance. This is due to our ability to build and maintain good budgets. We believe our track record for building and sustaining good budgets should carry significant weight in terms of strategic planning abilities and decision making. Whenever any school builds initial budgets, there will always be adjustments that have to be made over time due to the unknowns associated with the many assumptions reflected in those budgets. We have proven that we are able to make all the necessary changes within our budgets for the benefit of the school. This is another area where we do not believe a "does not meet the standard" should apply.

We thank you for your time and the inclusion of the above to ensure that hard copy submitted is in line with the electronic copy submitted to the district.
