Dear Mr. Gibson,

On April 4, 2024, our group, American Academy submitted a K-8 charter school application to the School District of Palm Beach County (See Attachment A). The 90-day window for the School District and School Board of Palm Beach County to review, provide a minimum of 7 days' time to make technical corrections, and approve or deny the application has passed as of the July 3, 2024 deadline.

Our group, American Academy, has presented the School District of Palm Beach County with an innovative and unique charter school application. Our proposed theme is a "Sports, Arts, and Classical Language" K-8 charter school. We used a team of six professional charter school consultants and an experienced real estate developer to guide and assist us through the charter application process with the intention of opening in August, 2025.

I would like to review some key points following our application submittal on April 4, 2024 below:

- The American Academy of Palm Beach Charter School application was submitted and accepted by the school district on April 4, 2024 via their Charter Tools Management system. (See Attachment A)
- No written feedback on the 110-page application and 555 pages of attachments has been provided at any time to the primary contact, Ms. Stacy Harris, listed on the submittal receipt.
- Our educational consultants have met with or contacted the School District of Palm Beach County Charter Schools Department regularly since the charter application submittal. On Monday, June 10, 2024 one of our educational consultants, in person, advised the Charter Schools Department Director that the American Academy of Palm Beach charter application had been submitted for review.
- Despite repeated phone calls by us and our educational consultants during the period following the June 10, 2024 visit, we have reviewed no official correspondence related to the American Academy Charter School application from the School District of Palm Beach Charter Schools Department or the Palm Beach County School Board. A review of the Palm Beach School Board agendas for May - July, 2024 show no approvals for the American Academy of Palm Beach K-8 Charter School application.

At this time, we, the American Academy founders wish to exercise our rights under Florida Statute 1002.33, (6)b(3)a, failing to act in the 90-day period, and 1002.33 (6)a(8)b(5)c(1) and appeal to the Florida State Board of Education for assistance. (See Attachment B). Also, we are submitting this appeal within the required 30-calendar day window to the State Board of Education and request that "the Commissioner convene a meeting of the Charter School Appeal Commission to study and make recommendations to the State Board of Education regarding its pending decision", due to the failure of the School District and School Board of Palm Beach County failing to act on the charter application in the required 90-day window.






