The CIE Annual Data Collection Has Begun

The CIE Annual Data Collection started in October and will end on November 30, 2009. All licensed institutions are required to report enrollment, graduation and placement outcomes using this online instrument. The CIE Annual Data Collection can be accessed at the Commission's website in the following manner.

- Click on your school's name
- Scroll down the Administration Page to "DATA COLLECTIONS" and choose "Student Enrollment/Graduation/Placement"

The FETPIP Data Collection Has Begun

The FETPIP Annual Data Collection began in October and will end on December 31, 2009. Participation in the FETPIP Data Collection is voluntary for all institutions that are licensed by the CIE. However, participation in the FETPIP Data Collection is required for those licensed institutions that are Workforce Development training providers.

- Click on your school's name
- Scroll down the Administration Page to "DATA COLLECTIONS" and choose "FETPIP"
- Enter the FETPIP Password for your school
