MAY MEETING WILL BE BROADCAST ON THE WEB

ASK LICENSURE

Why are there so many Commission deadlines?

Each month we all face numerous deadlines. It often seems as though there is never enough time to meet the bothersome requirements for these dates. No matter how hard we work, before we know it, the deadline has arrived.

The deadlines set by the Commission are crucial to ensure that you get your license, get the approval for a new program, or achieve approval, in a timely manner, for whatever action you may wish to undertake.

It takes a lot of time and a great deal of effort to process all the requests received by the Commission. Each month the Commission staff is responsible for processing documents received from the hundreds of schools that request actions by the Commission. We must then write the appropriate correspondence, check the content of all the documents submitted, make telephone calls, and verify the information contained in all the documentation submitted to make sure that it complies with the law and rules.

All requests must be correct and complete before they are presented to the Commission. The procedures used by the Commission staff for any action that has to be presented before the Commission must be completed three to four weeks prior to the scheduled meeting to assure that our staff has the time to finalize the package for Commission review.

If these deadlines are not met, or if your responses to queries from the Commission staff are not submitted in a timely manner, the review process may be delayed and some of the applications may not be processed as quickly as possible. If you foresee that there will be delays in submitting the application or a response, contact your assigned Program Specialist as soon as possible. As application packages are being finalized for one Commission meeting, new applications begin arriving for the next scheduled meeting and the process starts over again.

The Commission staff and each institution share a vital role in preparing documents for each Commission meeting. As staff members, we are charged with the responsibility of assuring that certain educational standards (as outlined in Commission Rule and the Florida Statutes) are maintained by each licensed institution. The job of providing the people of Florida a quality education is the responsibility that the owners and administrators of our institutions meet every day. With your understanding and assistance, we can work together to achieve these goals.
