SUBJECT: UPDATE: Perkins V Comprehensive Local Needs Assessment (CLNA) Labor

Market Alignment for Agriculture-Related Programs

Perkins V requires that each eligible recipient (school district or state college) complete a comprehensive local needs assessment (CLNA). A key required component of the CLNA is the alignment of local program offerings to labor market demand.

On March 3, 2020, Perkins eligible recipients received a memo from the Division of Career and Adult Education (DCAE) outlining the requirements for demonstrating labor market demand for programs in the agriculture cluster. The memo indicated that a previously planned primary source of evidence of labor market demand for some agriculture-related programs, documentation from the Florida Department of Agriculture and Consumer Services (DACS), would not be available. Agencies were instructed to utilize a different primary source, where available, or two secondary sources, as documented in "Overview of Labor Market Alignment Requirements and Standards" at http://www.fldoe.org/academics/career-adult-edu/Perkins/clna.stml.

However, we are pleased to share that DCAE has been able to secure letters from DACS documenting labor market need for the majority of programs in the agriculture cluster. These letters may be used as a primary source in local agencies' CLNA for the identified programs.
