EIAS Annual Database Workshop Canceled

As all are now well aware, state agencies' budgets have been drastically reduced because of the on-going economic downturn. During the special legislative session in January, state lawmakers and Governor Crist enacted a law that, effective January 27, reduced state employee travel to include only mission-critical activities and eliminated travel for conferences. Accordingly, Education Information and Accountability Services has canceled the 2009 Database Workshop. In lieu of our traditional three-day meeting in Orlando, we are reconfiguring the workshop into a virtual format. In this format, district personnel will be able to view pre-recorded presentations via the bureau's website at their convenience. Further details are forthcoming, and we will contact district personnel with instructions for participation well in advance. Don't Forget!

In Survey 5, all districts should be reporting data in the three data elements Dropout Prevention Primary Reason for Dropping Out, Dropout Prevention Secondary Reason for Dropping Out, and Dropout Prevention Possible Influences. All school districts should use the standardized form provided by the FLDOE, Bureau of Family and Community Outreach, Office of Dropout Prevention to collect these data and as a tool for data entry. 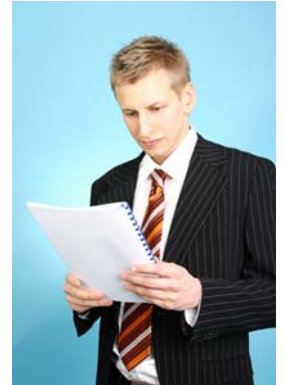

Final Reports

Please keep in mind that when a survey period closes, school districts should run final reports for that survey period. Helpful checklists for these reports are listed in Appendices R and S of the User Manual at http://www.fldoe.org/eias/dataweb/manual_0708.asp. Once you have completed the final reports, share them with appropriate district and school staff. Archiving them in a shared place is also useful for staff who have current and longitudinal data needs. Running and archiving these reports should be a standard activity in each district's Task Management System. Survey 5, 2007-08 was final on February 28, 2009, so be sure to run final reports now for this survey.
