SUBJECT: Industry Certification – Additional FTE in the 2011-12 Florida Education Finance

Program, 3rd Calculation

The Florida Education Finance Program (FEFP) includes additional full-time equivalent (FTE) membership in the calculation for students who earn industry certifications in career and professional academies and who graduate with a standard diploma. Based on the requirements in s. 1011.62(1)(o), F.S. and Rule 6A-6.0573(6), F.A.C., all of the following conditions must be met for the additional full-time equivalent membership funding for an "earning" industry certification:

- Student is enrolled in a registered career and professional academy.
- Student completes a certification on the "Industry Certification Funding List."
- Student receives a standard high school diploma.

The Department of Education has completed the 3rd calculation of the FEFP. This calculation is based on data submitted by districts through 2010-11.

The Department's management information (MIS) staff has created a student level report which your district MIS staff may access. The file name is DPSdd.GQ.F71102.Y11122; the format for this file is in DPS.DISTRICT.FORMATS.Y1112(F71102). For 2011-12, this calculation includes a total of 2,913.60 FTE. One eligible student generates 0.3 FTE in the calculation. You can calculate the number of students who generated the additional FTE by dividing your district's FTE total by 0.3 FTE.
