SUBJECT: Perkins IV Technical Skill Attainment Request Window

The Division of Career and Adult Education will accept final requests for additions to the **2011-2012 Perkins IV Technical Skill Attainment Inventories** (secondary, postsecondary-clock hour and postsecondary-college credit) between now and August 31, 2011. As you may recall, these inventories are comprised of evaluation instruments (industry certifications, state and federal licensures, third-party-developed assessments) that are deemed valid and reliable for reporting technical skill attainment (2S1, 1P1, 1A1) as required by Perkins IV.

The criteria for adoption of an evaluation instrument is that it be a valid and reliable measurement directly related to the learning outcomes of an occupational program and considered occupationally specific. In addition, the evaluation instrument requires a minimum of 150 hours of instruction or the equivalent of 3 credit hours.*

The following forms of assessment may be accepted to measure technical skill attainment:

- 1. federal or state regulatory agency-developed assessment instrument leading to licensure
- 2. industry-developed assessment instrument leading to industry certification
- 3. industry-developed end of program assessments

^{*}Many of Florida's CTE programs are not "occupationally specific" job preparatory programs (do not contain occupational completion points (OCPs)) that are tied to occupational SOCs (standard occupational classification) codes. In these instances the "occupationally specific" requirement is waived. However the requested evaluation instrument must be a valid and reliable measurement directly related to the learning outcomes of the CTE program. The 150 hours instructional threshold will be waived for CTE programs that are less than 150 hours in program length.

- 4. proprietary company-developed assessment instrument leading to certification of proficiency in one or more company product
- 5. third-party-developed assessment instrument
