SUBJECT: Senate Bill 2386 (Chapter 2010-151, Laws of Florida): New Requirements for Department of Education Contracts and Discretionary Projects/Grants

Please read the attached memorandum dated August 12, 2010. This communication provides information regarding the new requirements for the Florida Department of Education's (FLDOE) Contracts and Discretionary Projects/Grants to ensure compliance with SB 2386 (Chapter 2010-151, Laws of Florida). These new requirements directly impact the FLDOE's ability to complete the issuance of 2010-2011 award notifications for Adult Education and Family Literacy and English Literacy/Civics Education grants.

To comply with the new mandates of Senate Bill 2386, additional budget information is **required** from each Adult Education provider on a revised DOE 101-S Budget Form prior to issuing the 2010-2011 grant award notifications. To expedite completion of the revised DOE 101-S Budget Form, the Division of Career and Adult Education (DCAE) established the following process:

**Step One:** E-mail to the DCAE an electronic copy of your agency's final 2010-2011 budget for each Adult Education and Family Literacy and/or English Literacy/Civics Education grant by Friday, August 20, 2010 (see the attached chart for the county designation).

- West Team agencies should e-mail their budget(s) to Kenneth Plummer at: Kenneth.Plummer@fldoe.org.
- East Team agencies should e-mail their budget(s) to Ike Gibson at Ike.Gibson@fldoe.org.
- Include the following in the subject line of the email: Agency Name, Project Number, and the phrase "E-Budget."
