SUBJECT: Industry Certification Data Reporting

The Division of Career and Adult Education has developed a summary of reporting procedures for industry certifications earned by secondary students. The industry certification data elements are used for the following purposes:

Florida Education Finance Program, additional full-time equivalency calculation (Section 1011.62(1)(o), Florida Statutes)

Accelerated mechanisms component of the high school grades calculation Accountability measure for technical skill attainment (Carl D. Perkins Career and Technical Education Act)

The enclosed document explains how districts should report industry certification data, in various reporting scenarios, for the 2009-10 reporting cycle. All industry certification data is reported on the Vocational Student Course Schedule format (Survey 5).

SUBMITTING INDUSTRY CERTIFICATION DATA

All industry certification information must be submitted on the Vocational Student Course Schedule format, Survey 5 only. There are two data elements on this format that collect information on the industry certification:

<u>Industry Certification Identifier</u> – This is the 8 digit code that identifies the specific industry certification that is being attempted.

<u>Industry Certification Outcome</u> - An indicator of whether or not the student passed the industry certification or technical skill assessment taken/attempted.

Industry certifications earned or approved assessments passed as a result of participation in career and technical education must be reported linked to the career education programs and courses that lead to the student achieving the certifications.

Districts should also report any industry certifications earned by students who are not participating in career education; this data will be included in the school grades calculation. These should be reported using all zeros for the Program Code and Course Number fields. When submitting records with all zeros in the Course Number field, no matching Vocational Teacher Course record is required.

See below for some examples of how to report selected data elements on the Vocational Student Course Schedule.

Note: To be eligible for the additional FTE calculation in the FEFP, your district also must report the student earning the industry certification as being enrolled in a registered career and professional academy for the year in which the certification was earned as well as reporting the student's graduation information. ¹ The appendix also includes valid technical assessments for career and technical education programs that have been approved for the implementation of the Carl D. Perkins Career and Technical Education Act. Not all items included on this appendix are identified as industry certifications for purposes of implementing the Florida Career and Professional Education Act.

<u>Prior Year Reporting – Selected Data Elements</u>

One industry certification attempted/earned in 2009-10 linked to a secondary career and technical education course from a prior year (2008-09)

If the district does not have information on an industry certification until after the final update window for Survey 5, a method is available to report an industry certification identifier and industry certification outcome the following year linked to a prior year program and course. The option became available for the 2009-10 reporting cycle.
