Section 1: Introduction

The Florida Legislature passed House Bill (HB) 847 in the 2021 legislative session to establish the Florida Postsecondary Academic Library Network and revise online advising and library services for students. The oversight of the host entity for the Florida Postsecondary Academic Library Network was given to the Board of Governors' Office (Board Office) and the Florida Department of Education (FDOE).

In addition to these changes, HB 847 required the Commissioner of Education and the Chancellor of the State University System to submit recommendations by June 1, 2022, that identify which school district and charter technical career centers would receive access to appropriate resources of the Florida Postsecondary Academic Library Network. These recommendations were required to include analyses of resources needed to expand and support the career centers and their students.

This report of findings and recommendations is submitted pursuant to section s. 1006.73(6), Florida Statutes (F.S.), Florida Postsecondary Academic Library Network, which requires, "By June 1, 2022, the Commissioner of Education and the Chancellor of the Board of Governors shall provide a joint recommendation for a process by which school district career centers operated under s. 1001.44, F.S., and charter technical career centers under s. 1002.34, F.S., would access appropriate postsecondary distance learning, student support services and library assets."

Section 2: Background

Florida Virtual Campus

The Florida Legislature established the Florida Postsecondary Academic Library Network (Network) under the joint oversight of the Board Office and the FDOE. Its purpose is to deliver specified services to public postsecondary education institutions in Florida, namely all 28 Florida College System (FCS) institutions and all 12 State University System (SUS) institutions. The services under the Network are divided into two categories: Florida Virtual Campus (FLVC) Library Services and FLVC Distance Learning and Student Services (DLSS).

FLVC's Library Services division operates the centralized integrated library system (ILS), which provides books and other physical materials, electronic resources, and digital archive items to students at FCS and SUS institutions. Additionally, the Library Services division maintains electronic resources, digital services and open education resources, and library support and training. Collectively, public postsecondary institutions use these resources to support learning, teaching, and research needs.

FLVC's DLSS division organizes centralized resources that assist in the coordination and collaboration of articulation and access across the state. These resources are used by students, educators, and administrators across Florida to support academic advising, career readiness, distance learning, and provide educational resources. The following tools and resources are included: FloridaShines advising informational resources, statewide repositories and catalog, advising applications, transient and transfer resources, and professional services.

Historically, the services under the Network were administered by various statewide organizations, with responsibilities and duties articulated in Florida Statute. In 2020, the Board Office and FDOE selected the Northwest Regional Data Center (NWRDC) at Florida State University to serve as the host entity that administers the Network under the Florida Virtual Campus umbrella. The 2021 Florida Legislature appropriated a total of \$20,912,822 to the Network—\$9,076,322 under FCS specific appropriation 129B and \$11,836,500 under SUS specific appropriation 145A.

School District Career Centers

Students in Florida seeking postsecondary education have many different options for degrees or certificates and institution types. One option for students pursuing postsecondary career and technical education (CTE) are school district career centers and charter technical career centers. Section 1001.44, F.S., establishes the authority for school districts to establish career centers and s. 1002.34, F.S., establishes the authorization of charter technical career centers.

Career centers provide various postsecondary educational programs including career certificates, registered apprenticeships, applied technology diplomas (ATD), and continuing workforce education (CWE) courses/programs. Centers are considered a part of the district school system, which fall under the State Board of Education, the same governing entity for the FCS.

For 2020-21 there were 47 public, non-charter technical career centers and one charter technical career center. Table 1 shows a crosswalk of school district and associated career centers.

Historically, the services within the Network have been limited to postsecondary institutions that belong to FCS and SUS. Section 4 of HB 847 required the Commissioner of Education and the Chancellor of the Board of Governors to provide a recommendation for a process by which career centers would access appropriate postsecondary distance learning, student support services and library assets. Currently, career centers fund their libraries, media resources, and student services through workforce development funds, student tuition and fees, CAPE industry certification funds, and Perkins grants, among others.

Section 3: Methodology

To meet the requirement of HB 847, exploratory interviews were conducted with several career centers and district staff to provide a better understanding of the current landscape relating to the library, distance learning, and student services available to postsecondary students. Next, using the information gathered from the interviews, a survey was sent to all career centers to understand satisfaction with current services and assess interest in services that could be provided by the Network. With the results of the survey, FDOE and Board Office staff worked with FLVC to analyze appropriate resources and the cost, staff effort, and operational steps needed to expand appropriate services to eligible career centers.

Exploratory Interviews

The first step FDOE and Board Office staff took in this study was to conduct exploratory interviews with several career centers. One hour meetings with district staff were scheduled to discuss the following questions:

- **Library and Media Services:** What library and media resources are available to postsecondary students? For example, are there library holdings, digital archives and collections, online journals, e-books, or other e-resources? Who is responsible for making decisions regarding the availability of library resources that are geared toward your program offerings? How do you evaluate these resources and at what frequency? Who negotiates with vendors and holds contracts? Are there any collaborative contracts among the centers? Who pays? Are e-resources contracts on fiscal year or calendar year schedule?
- **Program Advertisement:** How do you advertise the list of available programs to prospective and current students? How are current and prospective students advised on the related industry certification or state/federal licensure requirements associated with the program? Are they able to see the full range of offerings, and identify which programs are offered by the modality? Are students able to view which courses are available online?
- **Instructional Design:** Do you employ instructional designers and/or have access to best practices in instructional design when creating course shells? Is there a process by which you evaluate the quality of online courses and/or online programs?
- **Advising Tools:** What current tools are available to help students with:
 - selecting a program of study aligned to their career interests;
 - understanding basic skills exit requirements (if applicable);
 - identifying the courses needed to complete a program;
 - identifying means by which they can transfer to other institutions; and/or
 - understanding residency and other state requirements?

From the information gathered in the exploratory interviews, a survey was developed to collect information from all career centers regarding their satisfaction with their current services and their interest in services that could be provided by FLVC.

Career Center Survey

Using an online survey instrument, career centers were asked to complete a 32-question survey in October 2021. The survey was open and available to respondents for four weeks. The survey included two parts: existing infrastructure and access to services under the Network.

Questions on existing infrastructure focused on the resources districts currently use related to supporting postsecondary students. Because career centers operate within districts that may share secondary and adult education students, some of these questions asked for responses by student type. The second section asked districts to indicate the services that would be beneficial to extend to career center students.

The survey did not require participants to answer all of the questions and responses ranged from 26 to 36 responses for questions reported.

FLVC Analysis

Based on the survey results and exploratory interviews, the NWRDC was asked to complete an analysis of cost and staff resources needed to expand access of a narrowed down number of Network services to career centers and their students. For each resource, the analysis included:

1. Florida Virtual Campus staff effort;
2. Estimated cost (one time and recurring);
3. Career center institutional effort;
4. Feasible timeline for implementation and associated operational steps; and
5. Any additional information the Commissioner of Education and Board of Governors Chancellor should consider when making their recommendation.

Informed by the analysis provided by FLVC and the survey results of institutions' interest in services, recommendations were made regarding what services to expand access to career centers.

Figure 1 shows the process by which FDOE and Board Office staff followed to identify the services to be recommended to extend to career centers.

Section 4: Recommendations and Next Steps

The following Network services are recommended to be expanded to career centers.

1. FloridaShines Website Content

A flagship service of FLVC, FloridaShines.org is Florida's Student Hub of Innovative Educational Services, an information-rich website of free online tools and resources to help students and adult learners succeed in school, earn a college degree, and embark on a rewarding career. Among the many features available on FloridaShines.org is the ability to easily research and compare all public colleges and universities in Florida to find the one that best meets the student's needs. The public may access all content in the FloridaShines Catalog at <https://www.floridashines.org/>.

Programs Catalog

FLVC manages the centralized, online catalog of all programs and certificates available from Florida's public colleges and universities, and many of the state's technical colleges and centers. The Catalog includes designations for quality and high-quality courses, along with indicators that enable students to quickly and easily identify online courses that have no textbook costs. The public may access the content at <https://www.floridashines.org/go-to-college/discover-degrees>.

Institution Profiles

In addition to course listings, the Catalog features detailed profiles of every public college and university statewide, and many technical colleges and centers. The profiles are a vital resource for high school seniors and their parents during the college search process. Profiles include detailed information such as admissions requirements and deadlines, tuition and costs, programs and degrees offered, campus-specific information, student demographics, housing options, and much more. College Readiness Planning Tools and Academic Success Worksheets

Through the FloridaShines Catalog, FLVC provides resources for students and parents to help them prepare for and be successful in college and careers. For example, checklists are available for students in grades 9-12 to prepare to enroll in college upon graduation. Additionally, resources on tips and tools for success in college – like study skills, time management, and note-taking – are available as well. The public may access this content at <https://www.floridashines.org/go-to-college/get-ready-for-college>.

Testing Center Database

Some virtual courses require students to take proctored exams. A proctored exam is one that is overseen by an individual (called a proctor) who monitors or supervises a student while he or she is taking an exam. The proctor ensures the security and integrity of the exam process. FLVC maintains a testing center database to help prospective and current students locate sites that offer testing services. 2. Quality / Instructional Design Network

FLVC relaunched the Florida Instructional Designer Network (FL-IDN) in June 2021, in partnership with the FCS, SUS, and the Independent Colleges and Universities of Florida (ICUF). The FL-IDN serves as a statewide professional development network and community of practice supporting instructional/learning designers and technologists, learning engineers, and educators throughout Florida. The network sponsors professional development events and other collaborative opportunities to help instructional design and technology professionals share research and best practices, gain the knowledge and skills to support faculty, and support student success. FL-IDN has steadily grown to over 300 regular participants. Once services are extended to school district career centers, a primary point of contact from each center will be established to serve as a liaison to FLVC. FLVC staff will interact directly with liaisons on how to access opportunities for instructional design support.

3. Professional Development and Training

As part of utilizing the recommended tools and resources, career centers would receive training in administrative management and usage of the FloridaShines services (such as uploading data to the catalog, managing reports, etc.). The other aspect of training would include professional development opportunities related to relevant topics in higher education (in the form of webinars, symposia, statewide meetings, summits, etc.). Once services are extended to school district career centers, a primary point of contact from each center will be established to serve as a liaison to FLVC. FLVC staff will interact directly with liaisons on how to access opportunities for professional development and training related to the selected services.

Table 2 shows a summary of the recommended services to be expanded to career centers and their associated costs, FLVC staff effort, and career center effort. In total, the cost to expand these services to career centers is \$241,500 in recurring funding for FLVC. Current staff at career centers will absorb the duties related to implementation of these services.

The recommendations presented in this report are designed to support the statewide scaling of distance learning and student services to prospective and current students in CTE programs at district career centers. By expanding access to the FloridaShines Catalog, the Quality/Instructional Design Network, and Professional Development and training, school district career centers will receive tools and resources to better support quality instruction and help students prepare for and succeed in college and career. If these services are to be expanded to career centers, the SBOE would include funding for the expansion in its 2023-24 legislative budget request.

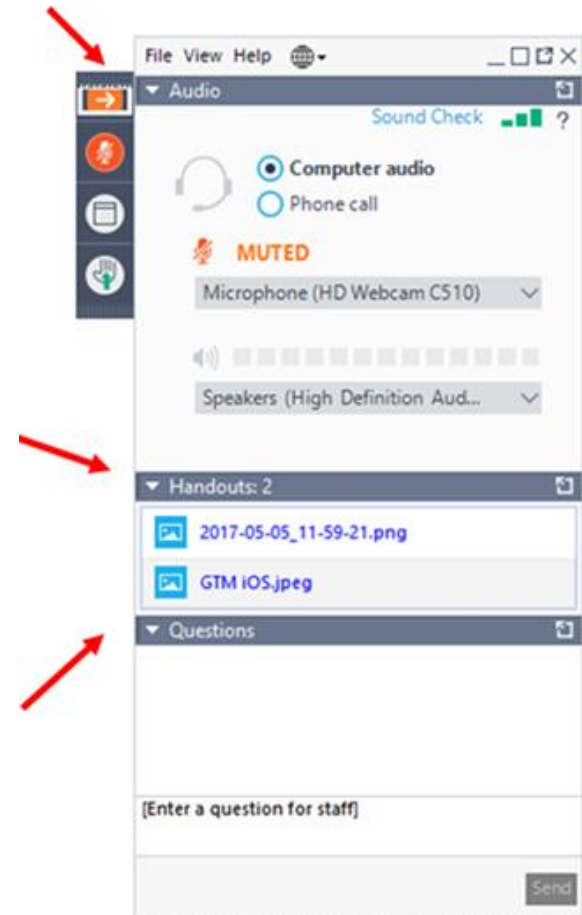

Overview of HB 847

Background

- In 2021, the Florida Legislature passed HB 847 to revise statutory provisions related to Florida's statewide Internet-based catalog, online student advising services, and library services. Currently, the services within the Florida Postsecondary Academic Library Network are limited to postsecondary institutions that belong to the Florida College System and State University System. The Northwest Regional Data Center (NWRDC) is the host entity.

Charge

- HB 847 charges the Commissioner of Education and the Chancellor of the Board of Governors to provide a recommendation for a process by which career centers would access appropriate postsecondary distance learning, student support services and library assets. It establishes June 1, 2022, as the deadline for the recommendation, and requires the recommendation to include an analysis of the resources necessary to expand access and assets to centers and their students.

Integrated Library System

- Integrated Library System (ILS) and Discovery Tool -- Alma/Primo
 - All library resources, both physical and electronic
 - Entire information lifecycle:
 - Acquisitions, Cataloging, Circulation, Course Reserves, ILL, Serials, etc.
 - Allows users to discover physical and electronic library resources at their FCS or SUS institution from a single search portal
 - Statewide “Universal” Library Catalog and UBorrow Delivery Service
 - Allows simultaneous search of all SUS and FCS libraries – approximately 20 million titles
 - Users may request items to be delivered to any FCS or SUS campus
 - Interoperability with other campus systems (SSO integration, LMS, Citation Management, etc.)
 - Cost is based on number of institutions, number of records, number of named users

Electronic Resources

- **Statewide collection** of electronic resources (databases, scholarly journals, newspapers, magazines, academic videos, e-books etc.)
 - Price negotiations, contracts, licensing
 - Statewide appropriation for all FCS and SUS institutions
 - Cost for each resource is based on FTE per institution
 - Over 255,000 academic full text resources
- **Group Licensing** for electronic resources paid by institutions
 - Price negotiations, contracts, licensing
 - Academic content from 40+ vendors
 - Cost for each resource is based on FTE per institution
 - 560 subscriptions
- **OpenAthens Authentication Platform**
 - Authentication and access for e-resources
 - OpenAthens – SAML, integration with IdP at all 40 institutions
 - Authenticates user from any online point of access, dramatically enhancing access to content
 - Cost is based on size of institution

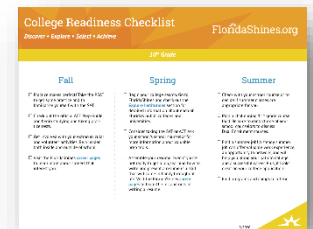
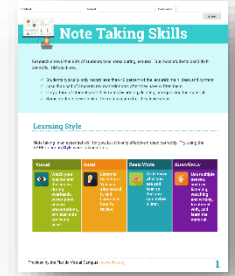

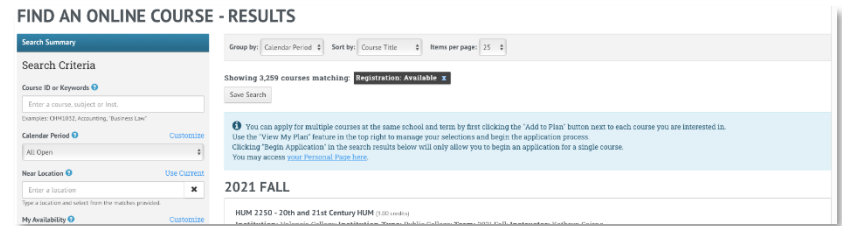

- **Common Pre-requisites Manual**

- State database of record for all prerequisite courses required for specific programs at every Florida public college and university.
- Helpful planning tool for transfer student in Florida planning to be admitted to an upper division program.
- No additional cost to participate. Requires state approval to include institutions and programs.



- **Testing Center Database**

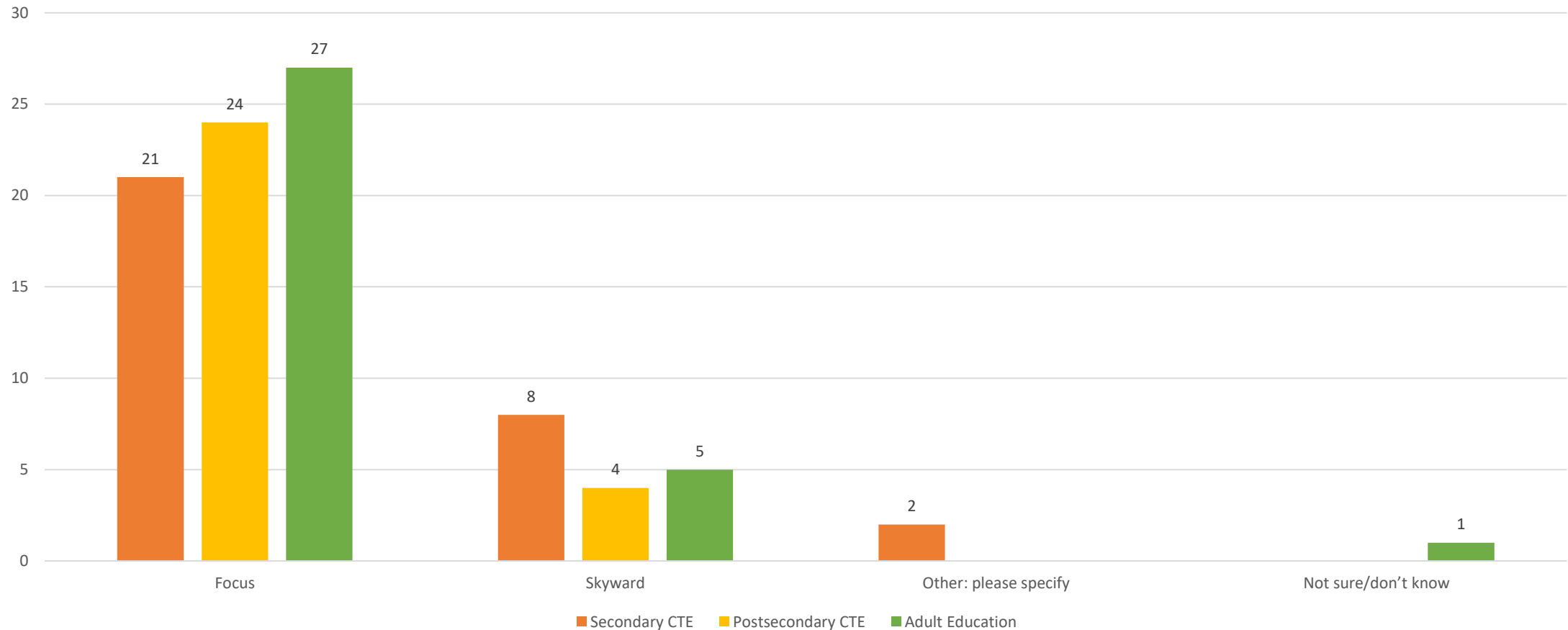

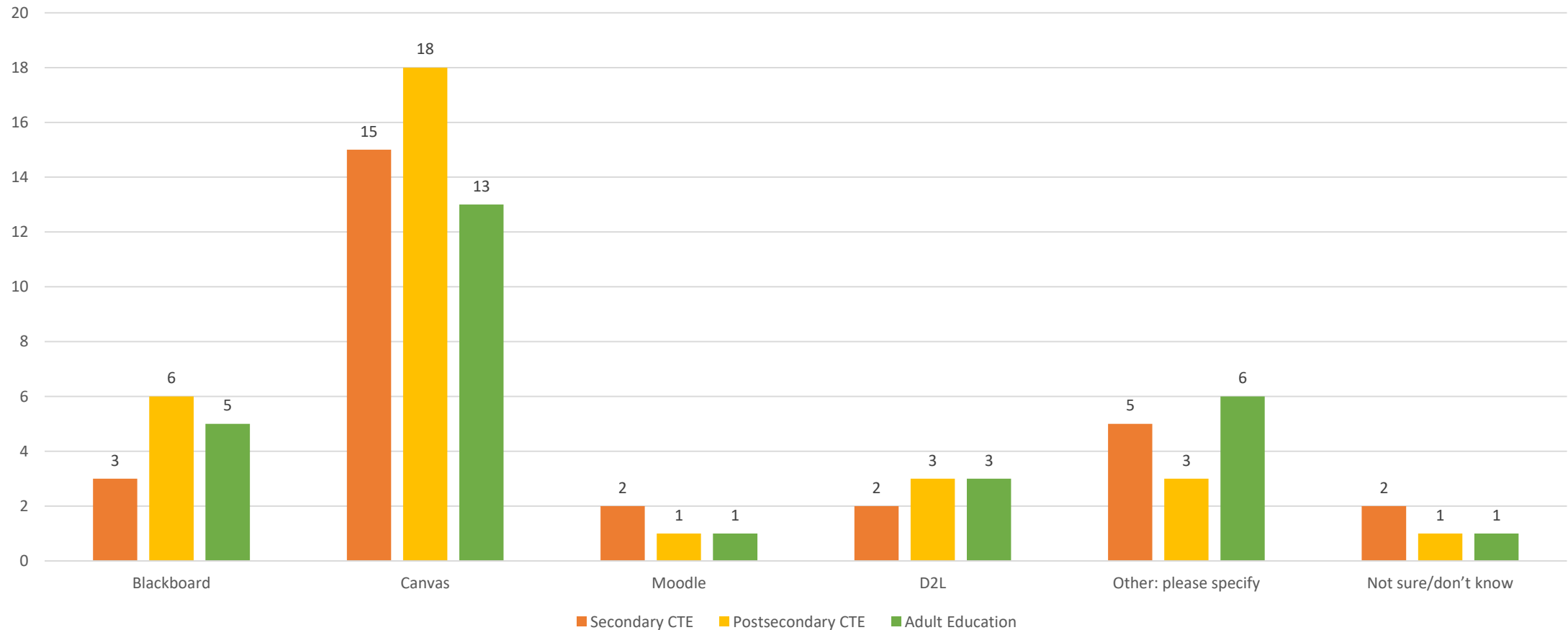

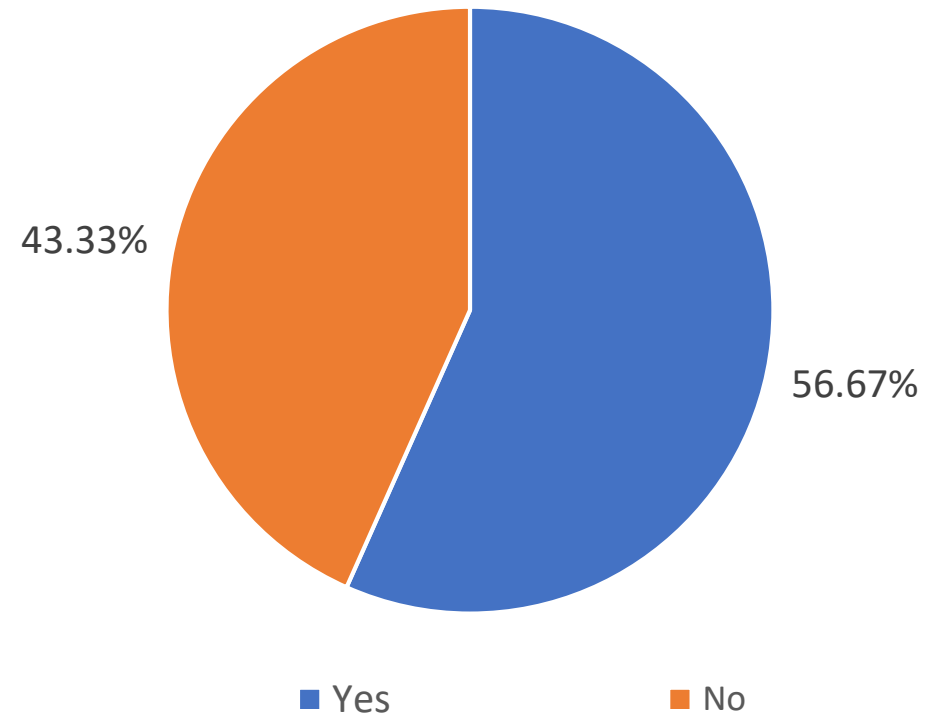
Select the learning management system available to students in your district. n=36



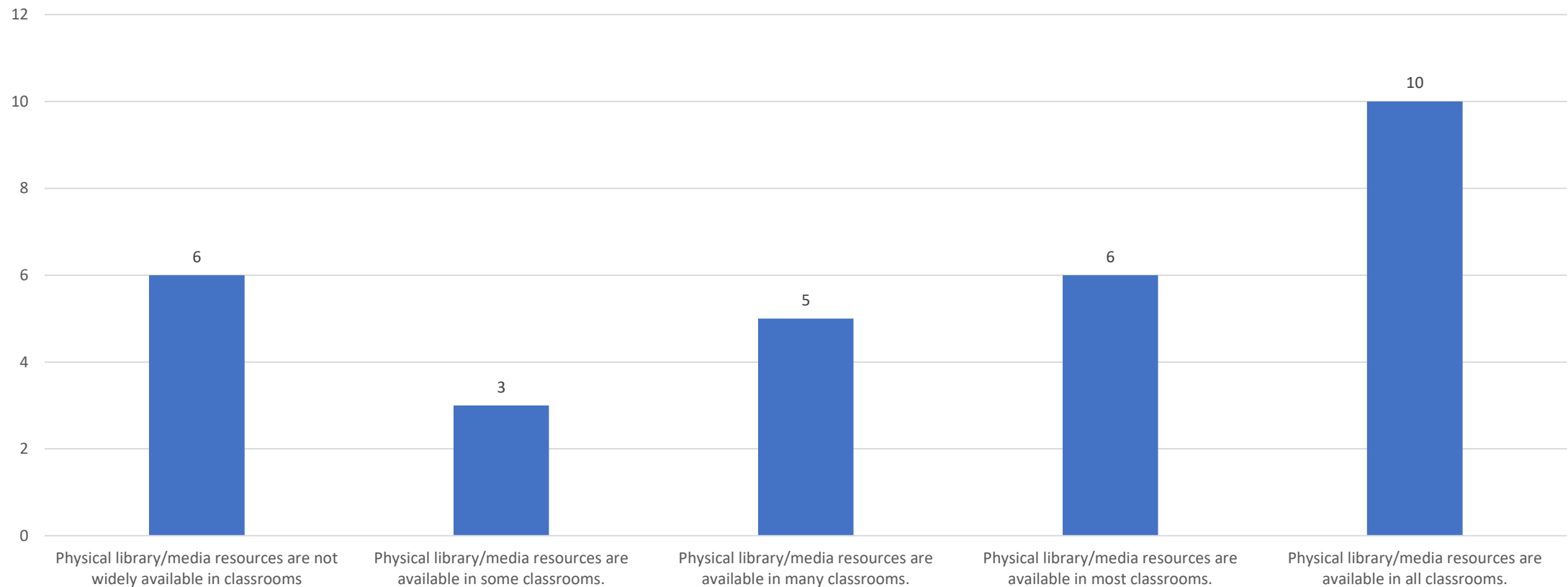

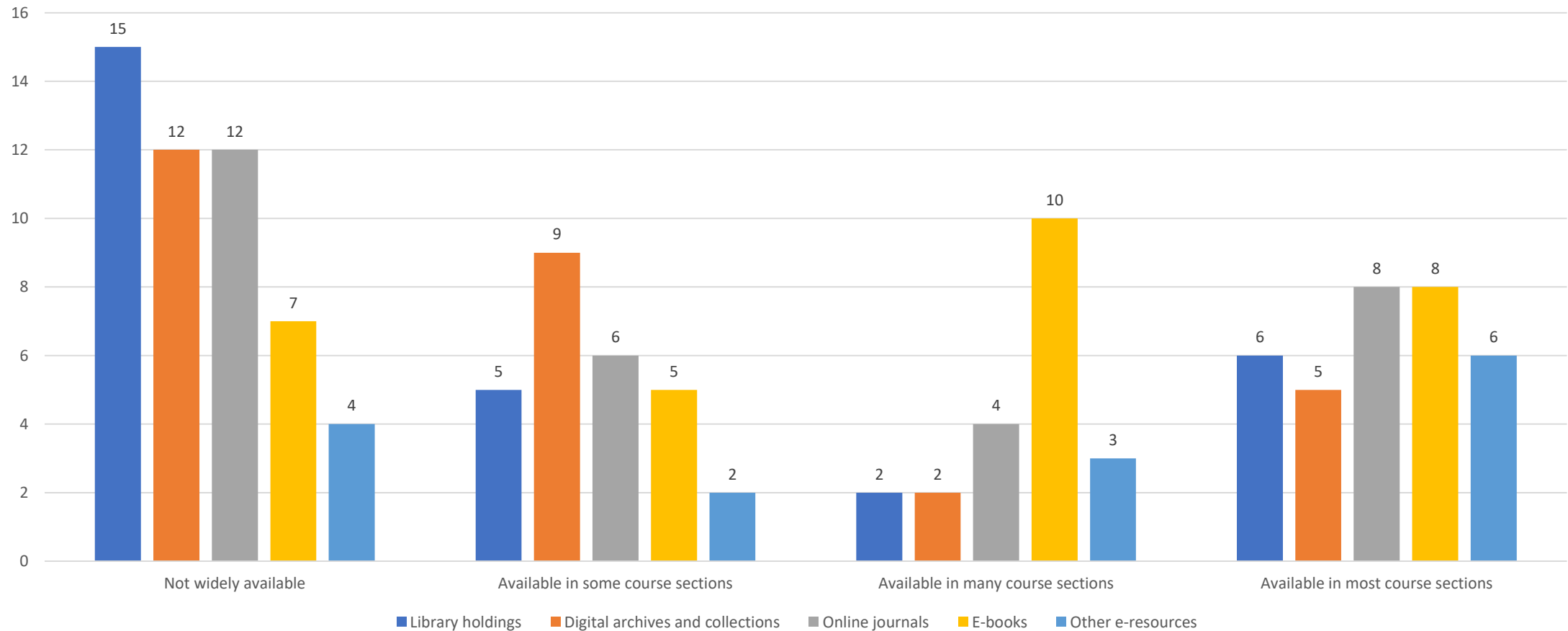
Does your center have a physical centralized library/media center? n=30

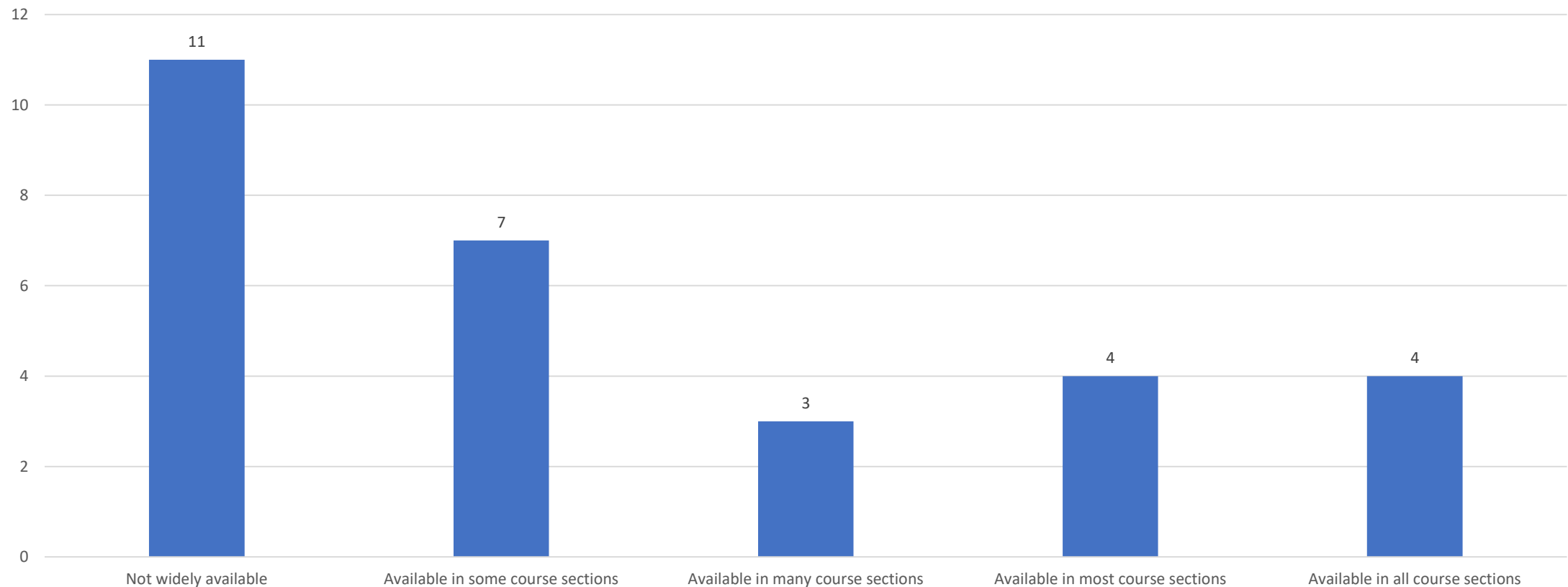
What electronic library and media resources are available to postsecondary CTE students? n=31



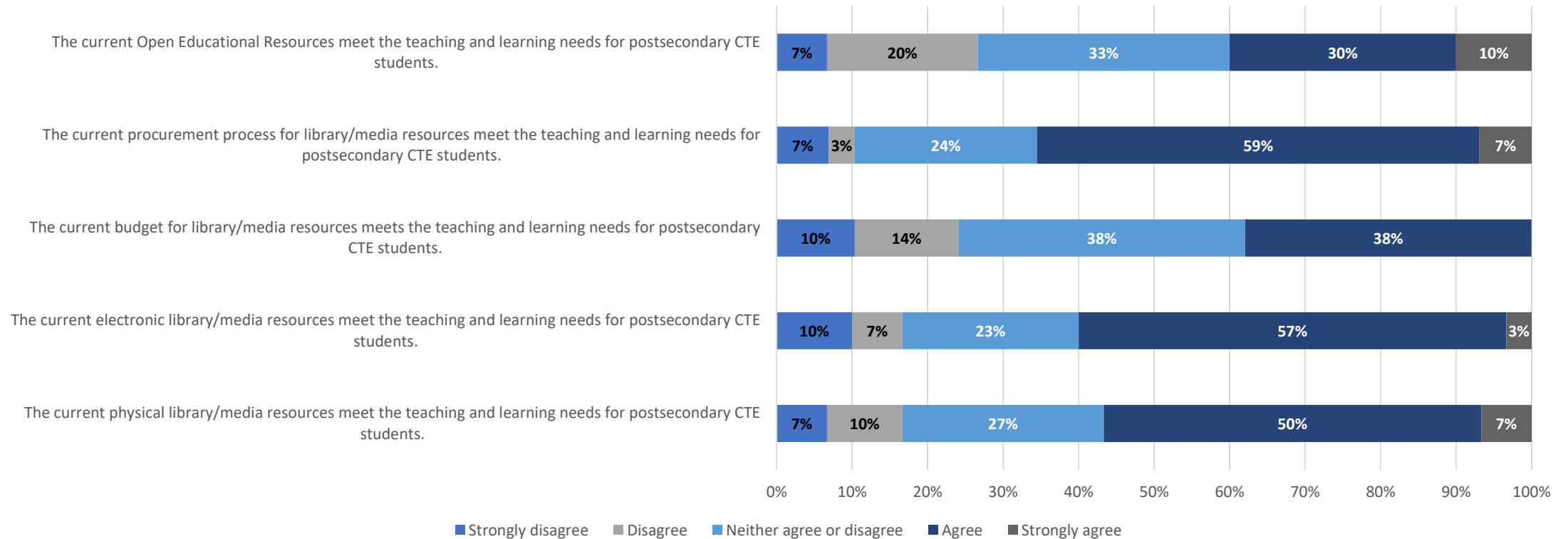
Who makes decisions about purchasing library materials (either print or electronic)?

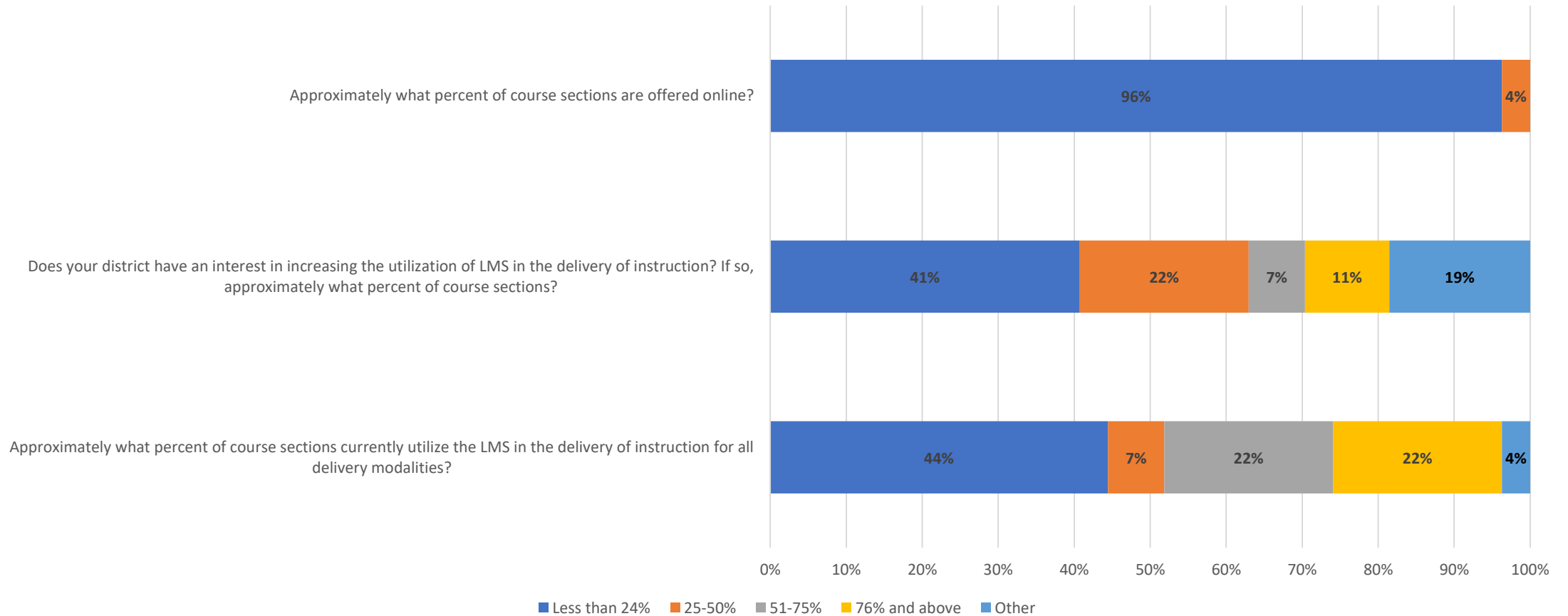
What is the availability of open educational resources (OER) for postsecondary CTE students? n=29



Rate your agreement with the following statements related to library/media resources. n=29-30



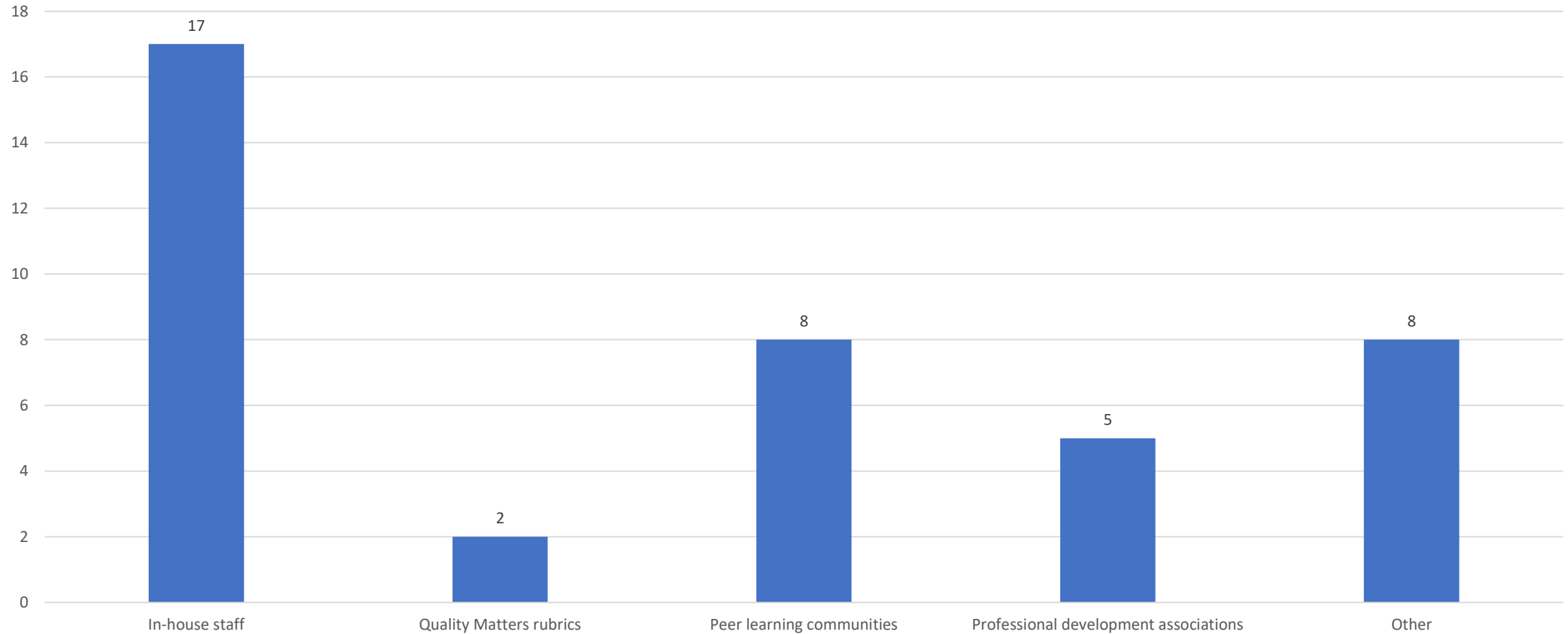
Instructional Design and Delivery n=27



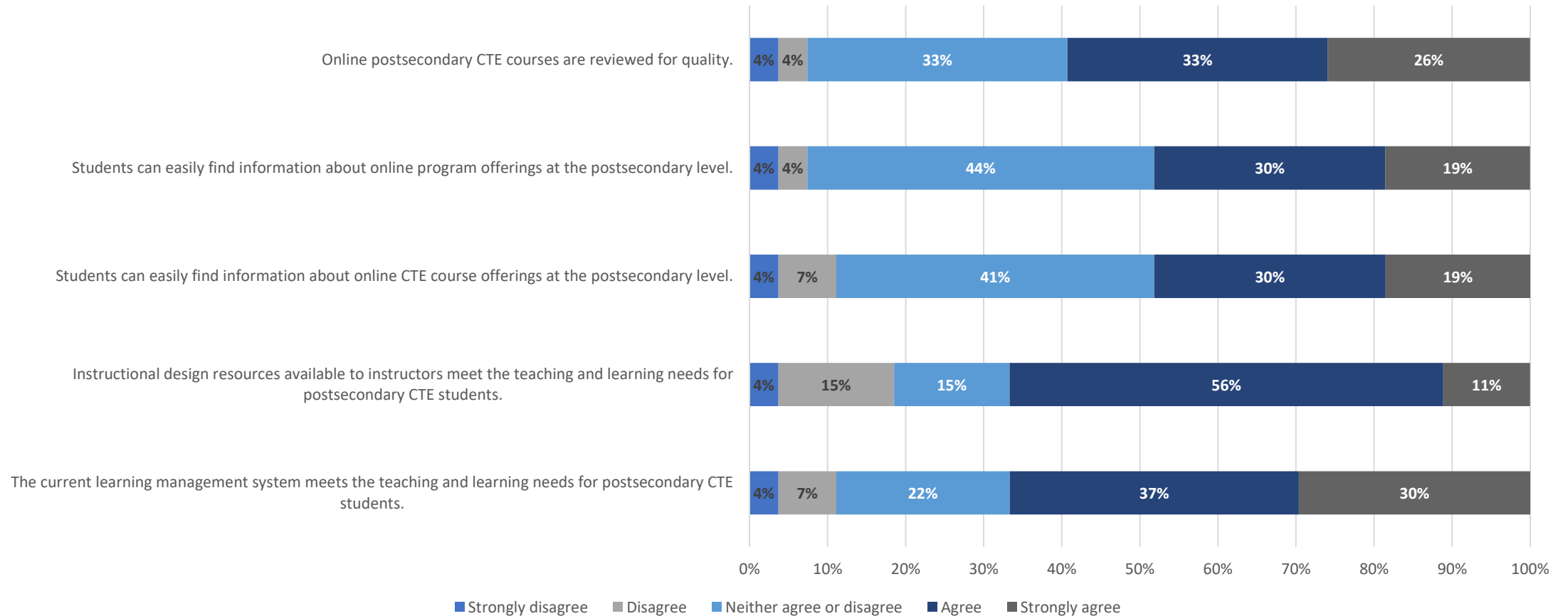
What resources are available for instructors related to instructional design when creating course shells?

In 2021, the Florida Legislature passed House Bill (HB) 847 to revise statutory provisions related to Florida's statewide Internet-based catalog, online student advising services and library services. The bill required that a recommendation be developed for a process by which career centers would access appropriate postsecondary distance learning, student support services and library assets.

As a first step in the process, the Florida Department of Education requested that all districts operating career centers complete a survey in fall 2021 to inform the identification of appropriate services. A copy of survey findings is attached for reference. Based on satisfaction with existing resources and interest in services under the Florida Postsecondary Library Network, we identified the following services as potentially appropriate for career centers to access.
