## Dear Superintendent Tomyn:

This letter is to inform you of findings of noncompliance related to Marion County School District's 2013–14 exceptional student education self-assessment monitoring process, including validation by bureau staff and reassessment by the district. Records were reviewed for Secondary Transition, Individual Educational Plan Implementation, Department of Juvenile Justice and Restraint and Seclusion. Findings of noncompliance were identified for Restraint and Seclusion. Two prongs of correction are required: student-specific correction and demonstration of 100 percent compliance. Your district has completed both prongs of correction and no further corrective actions are required.

In addition to the self-assessment referenced above, a Matrix of Services review was required. Marion County School District was required to review nine matrices for students reported at the 254 or 255 cost factors for weighted funding through the Florida Education Finance Program. Cost factor discrepancies were found in one of those records. Verification of correction was submitted by your school district.

The following is a summary of the school district's timely correction of student-specific findings of noncompliance.
