6-week webinar series begins

This webinar is a companion to the Classroom Success course, but anyone interested can attend. Participants will learn about evidence-based frameworks to prioritize goals using **active engagement** and a **layer cake of teaching strategies** promoting learning and positive behavior. To achieve the intensity needed and promote generalization for students with autism, the importance of teaching and learning across everyday classroom activities will be highlighted. Video examples and audience participation will be used to illustrate how to apply this model to both in-person and virtual classrooms, and to teach parents strategies to support their child's learning in everyday activities at home.
