Pilot testing is designed to collect information about the performance of new test items to ensure that they are appropriate for use.

We are currently recruiting for the following test fields:

• Speech-Language Impaired K-12

#### Location and Dates

Computer-based pilot testing opportunities are available now at Pearson Professional Centers throughout Florida. Registration is open now for interested and eligible participants.

Advantages of Pilot Test Participation (There is no cost to participate in the pilot test.)

- For each test form completed, participants will receive **\$75 cash in the form of a check** (mailed to the address provided).
- Participants will respond to items that may appear on future versions of the test for which they register.
- Participants will gain practical testing experience.

#### Who Is Eligible To Participate?

- Teacher education students
- Recently certified educators or degree holders (0-3 years)
- Recent examinees

Note: College and university faculty are not eligible to participate in the pilot testing.

#### **Test Information and Scores**

Each pilot test includes approximately 90 multiple-choice questions. Pilot test sessions are two hours and fifteen minutes in length. Eligible candidates may register for up to two sessions. The second registration can only be scheduled after the first pilot test session is completed (consecutive pilot test appointments are not available).

Because information from the pilot test will only be used to evaluate the test items, score information will not be provided. Pilot test results will be analyzed as group data only and will be kept confidential. No information that could identify a particular individual will be released.

Examinees will receive compensation upon verification of satisfactory participation (defined as a completed test form with at least 25% of items answered correctly). Examinees will be required to complete a W-9 form prior to receiving compensation, are responsible for any applicable taxes, and should allow 10-12 weeks for processing.

Eligible candidates should visit the pilot test website to register: https://home.pearsonvue.com/espilot/ftce After an examinee schedules a pilot test appointment, Pearson VUE will email a confirmation listing the test date and testing time, the address and phone number of the test center, and directions to the test center. If an examinee is unable to keep the appointment, a cancellation should be made at least 24 hours before the scheduled test time.
