Consistent with the requirements of Title 34, section 300.602, Code of Federal Regulations, for state educational agencies to report annually on the performance of each local educational agency (LEA), on the targets in the State Performance Plan (SPP) no later than 120 days following the state's submission of its Annual Performance Report or APR, the FDOE BEESS has posted the updated LEA Performance Reports that meet this requirement.
