Introduction	
Welcome & Comments	<p>Chair Ed Massey called the meeting to order at 1:14 p.m. He recognized Chancellor of the Florida College System, Kathy Hebda, who then announced that a vacancy had occurred in the Office of Articulation and that former Chancellor of Career and Adult Education, Rod Duckworth, would be taking over as Executive Director of Articulation starting on June 3, 2019.</p> <p>Dr. Massey then welcomed members and attendees to the meeting and then gave an opportunity for everyone present to introduce themselves.</p> <p>After introductions, Dr. Massey mentioned how important the ACC is, as a statutorily-authorized committee appointed by the Commissioner of Education, and how Florida articulation policies are the bedrock for student success. He thanked members for volunteering their time to serve in such an important capacity as the ACC focused on student transition from secondary to postsecondary education and the workforce.</p> <p>Dr. Massey then noted that Item 3 on the agenda would switch places with Item 2, with the remaining agenda items to follow consecutively.</p>

1. Approval of February 27, 2019 Meeting Minutes	<p>Chair Massey asked members if there were any changes to the meeting minutes; there were none. Motion to approve the minutes was made by Dr. Buchanan and was seconded by Dr. Hudson; the meeting minutes were approved by unanimous vote.</p>
Discussion Item	
2. 2019 Legislative Update	<p>Bethany Swanson, Director of Legislative Affairs, presented an update on education priorities, primarily focused on students, teachers and parents, that were passed by the 2019 Florida Legislature.</p> <p>The targeted priorities of the 2019 Legislation Session centered around results-based funding, support for teachers, safer schools, expanded school choice options, college</p>

and career pathways, and civic literacy. As a result of the legislative session, thirty (30) education-related bills passed.

Of particular interest were increases in funding; \$75 increase in per student funding, \$284.5 million increase in Best and Brightest funding for principals and teachers, free liability insurance for school personnel, \$75 million for mental health training and care, \$10 million for teacher professional development in computer science education, \$10 million for preapprenticeship and apprenticeship programs, among others.

4. Florida College System Rule Development Update	Dr. Carrie Henderson provided a brief update on rule development and revisions that the Division of Florida Colleges is working on related to civic literacy competencies, postsecondary instruction, and the common placement test.
5. Dual Enrollment, Credit-by-Exam Legislative Update	Ms. Amanda Walker provided a brief update on legislation that did not pass the 2019 Legislative Session related to dual enrollment and the award of credit for military service and experience. Based on past experience and national trends, it is possible that these issues will be considered again in a future legislative session.
Other Business	Dr. Massey asked for a status report on the Mathematics Pathways Project. Dr. Henderson indicated that there is a June 27 Institute meeting to unveil the recommendations of the three workgroups involved in the project. All ACC members are invited to participate in the one-day meeting. There will be fourteen (14) recommendations surrounding the topics of: state articulation policy, the Statewide Course Numbering System, reinvigorating mathematics discipline committees, gateway math courses, application and overlap of learning outcomes, and course prerequisites.
