| Element Name: Student Number Identifier, Florida | |
| Definition/Domain | |
| <p>A ten-character code used to uniquely identify a student. The number must be maintained for all PK-12 students, adult general education students and postsecondary vocational students.</p> <p><u>If the student has a social security number, the Florida Student Number Identifier equals the social security number followed by an "X."</u></p> <p align="center">nnnnnnnnX Example: 123456789X</p> <p>If a student <u>does not</u> have a social security number, the school district should assign a number using the common method statewide.</p> <p><u>First Two Digits</u></p> <p align="center">NN For any student entering a Florida school district for the first time who does not have a social security number, the first two digits will represent the district of initial entry into the Florida school system.</p> <p><u>Last Eight Digits</u></p> <p align="center">NNNNNNNN The last eight digits are district-defined in such a way as to result in a unique student number within the district where the number is originally assigned.</p> <p>If a student does not have a social security number at the time of entry, but later produces a social security number, the district must update the Florida Student Number Identifier with the verified social security number.</p> <p>The Florida Student Number Identifier will be required for state reporting, other documents, interdistrict record transfer (F.A.S.T.E.R.), permanent records, postsecondary transcripts and application to postsecondary institutions, report cards and district exit paperwork.</p> <p>See the Social Security Number and Florida Student Number Identifier - Alias data elements for more information concerning changes to the Florida Student Number Identifier.</p> <p>NOTE: Districts may maintain a separate local student number identifier.</p> | |
