### AAA Scholarships - Benefits

- Convenient and Consistent Mechanism for Businesses to Fund Scholarships in Multiple States
- Target Redirected Taxes Ensuring Use for Educational Expenditures Rather Than to Bureaucracies Which May Limit the Amount of Resources Spent Directly on Education
- Direct Resources to Students Most in Need of Educational Options and Least Likely to Benefit From General Increases in School District Budgets
- Provide a Meaningful and Convenient Way for Businesses to Address Concerns about the Quality of Public Education and Its Impact on Communities and Economic Development
