**SUBJECT:** 2024-25 Class Size Compliance

Compliance with class size reduction requirements for the 2024-25 fiscal year is calculated at the classroom level for traditional public schools, as required by [section \(s.\) 1003.03\(1\), Florida Statutes](#) (F.S.); at the school level for charter schools, as required by [s. 1002.33\(16\)\(b\)3., F.S.](#); and at the school level for district-operated schools of choice, as required by [s. 1002.31\(5\), F.S.](#) The attachments list districts with traditional public schools, charter schools and district-operated schools of choice that are out of compliance with class size requirements. These lists are based upon class size information submitted for the October 2024 full-time equivalent (FTE) student enrollment survey and updated through December 15, 2024.

Statewide, 439 out of 9,053 traditional public school classrooms, 74 out of 702 charter schools, and 267 out of 2,962 district-operated schools of choice are out of compliance with the constitutional requirement to maintain class sizes of no more than 18 students in kindergarten through grade 3, 22 students in grades 4 through 8, and 25 students in grades 9 through 12. Section 1003.03(4), F.S., requires school districts and charter schools that have not complied with class size requirements to submit a certified plan to the Commissioner of Education by February 1, 2025, explaining the actions the district or charter school will take to ensure compliance by October 2025. In 2023, the Florida Legislature removed the financial penalty assessed to districts and schools that do not comply with class size requirements. Accordingly, the 2024-25 class size process will be complete with the submission of all required compliance plans.
