Differentiated Monitoring System (DMS) 2.0 Monitoring Activities — Office Hours and Comprehensive Timeline

Review the following clarifications regarding the DMS 2.0 Office Hours Technical Assistance (TA) Calls:

- Tier 1 Monitoring TA: These drop-in style calls are open to all local education agencies (LEAs) and are designed to provide general TA related to monitoring activities. Participation is encouraged as needed.
- Tier 2 Monitoring TA: These scheduled calls offer in-depth discussions on specific focus areas identified for monitoring. The LEAs previously notified for Tier 2 monitoring during the 2025-26 cycle, must attend for targeted support. The Tier 2 TA call scheduled for October 23, 2025, will provide an overview of Tier 2 activities.
- Tier 3 Monitoring TA: These flexible calls provide individualized, or follow-up assistance, tailored to specific needs. Selected LEAs will be contacted directly by their assigned team lead. Following the initial TA call on October 28, 2025, which will provide an overview of Tier 3, LEAs may join subsequent calls as needed, based on guidance from their team lead.

Florida Instructional Materials Center for the Visually Impaired (FIMC-VI) Tip for Building Stronger Programs for Students with a Visual Impairment (VI)

FIMC-VI is encouraging educators and administrators to incorporate common assessment forms when building programs for students with a VI.

- Ask yourself: Does your vision program currently use standardized, program-wide evaluation templates for required VI assessments? Have they been reviewed and updated since the recent revision to Rule 6A-6.03014, F.A.C.?
- Using common templates offers several key benefits:
 - o Ensures all required areas are addressed;
 - Promotes consistency among VI staff;
 - Facilitates information sharing;
 - Supports uniform practices; and
 - o Enhances reliability for parents and district/LEA personnel.
- It is important to set time aside annually to review and update your forms to ensure they remain relevant and effective.

The National Center on Accessible Digital Educational Materials & Instruction (NCADEMI)

NCADEMI has published a new resource to help state and LEAs improve the accessibility of materials provided in schools: Quality Indicators for the Provision and Use of Accessible Materials in Prekindergarten (Pre-K)-12 Systems. They are organized into two sets; one aligned with the Americans with Disabilities Act Title II rule (<u>Accessible Digital Educational Materials</u>) and the other aligned with the Individuals with Disabilities Education Act (IDEA) (<u>Accessible Formats</u>).

To help states and LEAs get started with the Quality Indicators, the NCADEMI team is hosting a webinar series from October 9 to December 18, 2025. LEAs can promote the new resource and webinar series with assistance from the Quality Indicators Dissemination Kit provided by NCADEMI. The Florida Low Vision Initiative (FLVI) Newsletter

FLVI, an IDEA-funded state project, through Florida Supportive Services for Students with VIs, is accepting referrals for the 2025-26 school year. Low vision services are also available to students with low vision, Pre-K four-year olds through eighth grade, who receive direct instruction from a teacher of students with visual impairments, as documented in the student's individual educational plan (IEP).

FLVI participants:

- Receive a no-cost, comprehensive low vision evaluation;
- Are eligible to receive glasses and a wide variety of portable optical aids, when prescribed for specific low vision needs; and
- Receive training in the use of glasses and portable optical aids.

² Report initial evaluations exceeding timeline monthly for the current school year (FFY 25) beginning October 2025. For instance, if an evaluation is due on 10/17/25, it will be considered as exceeding the timeline for October if it is completed after that date. A list including the student's identification number, reason for the delay, consent date, evaluation completion date, ESE eligibility category and if compensatory services were provided, organized by the number of days exceeding the timeline (i.e., 10 days beyond, 11-20 days beyond or 21 or more days beyond the timeline) must be uploaded to the district-specific Indicator 11 ShareFile folder.

³ All LEAs will submit Indicator 11 data for FFY 24. Consents received between 07/01/2024 and 06/30/2025 will be submitted via Single Sign-On.
